### investment objective and investment policy

Investment objective. The purpose of the subfund is to increase the value of assets as a result of an increase in the value of investments. **Investment policy.** The shares of the equity and debt parts in the subfund's asset value will be as follows:

- 1) starting from January 1st in the year in which the subfund reaches its Defined Date (i.e. 2050), the share of the equity portion will not be greater than 15% and will be gradually reduced so that as of December 31 of that year it amounts to zero %, and the share of the debt part may not be less than 85% of the subfund's asset value;
- 2) in the period of 5 years preceding the Defined Date, the share of the equity part may not be less than 10% and greater than 20% of the subfund's assets, and the share of the debt part may not be less than 70% and greater than 90% of the subfund's asset value; during this period the share of the equity part will be gradually reduced in favor of the debt part,
- 3) in the period of 5 years preceding the period referred to in point 2), the share of the equity part may not be less than 25% and greater than 50% of the subfund's assets, and the share of the debt part may not be less than 50% and greater than 75% of the subfund's asset value,
- 4) in the period of 10 years preceding the period referred to in point 3), the share of the equity part may not be less than 40% and greater than 70% of the subfund's assets, and the share of the debt part may not be less than 30% and greater than 60% of the subfund's asset value,
- 5) starting from the day of the creation of the subfund until the commencement of the period referred to in point 4), the share of the equity part may not be less than 60% and greater than 80% of the subfund's asset value, and the share of the debt part may not be less than 20% and greater than 40% of the subfund's asset value. The sub-fund is actively managed.




### unit value change chart (PLN)
